# EAST BUDLEIGH WITH BICTON PARISH COUNCIL 

Minutes of the East Budleigh with Bicton Parish Council Meeting<br>held on Tuesday, 28 March 2017<br>in the Village Hall, East Budleigh.

There was no member of the public present.
PCSO Chantalle Major was not in attendance but submitted her police report, a copy of which is in the Minute file and a copy on the notice board.

## The Parish Council Meeting began at 7.30 pm .

It has been proposed and agreed that members of the public be allowed to speak for $\mathbf{3}$ minutes at the beginning of the meeting. This time scale will run to maximum of 30 minutes, therefore allowing 10 people to speak. This will bring EBPC in line with other town/parish councils. Members of the public wishing to speak on an Agenda item are requested to inform the clerk no later than 27 March 2017. It should be noted that this is NOT a question and answer session, it simply provides a vehicle for the public to make the council aware of views of the public before discussing agenda items.

1. APOLOGIES: District Cllrs G Jung, S Hall and T Wright.
2. MINUTES: The Minutes of the February 2017 Parish Council meeting were proposed, seconded and signed as a correct record by the Chair.
3. DECLARATIONS OF INTEREST \& RISK ASSESSMENT: There was no declaration of Interest and Risk Assessment was checked by the Chair.

## 4. MATTERS ARISING

4.1 Drain clearance difficulties in Hayes Lane - Cllr Tweedie reported that he is waiting for the results of a survey to ascertain the problems caused by a blockage in a nearby drain.
4.2 Budleigh Traffic Group - The Chair reported that a Traffic Order concerning Knowle Village is to be passed in September. It was suggested that extensions were needed to include Badger's Holt and Frogmore Road.

The Chair reported that Budleigh Salterton Town Council intended to write to East Devon District Council (copy to Devon County Council) regarding the unsatisfactory sanitary arrangements used by the travellers who have occupied a nearby lay-by for several months (B3178).
4.3 Annual Parish Meeting - The APM is due to take place on Tuesday, 25 April 2017 at 7pm. Usually a speaker is invited but the Chair has suggested that the time allocated should be spent discussing the progress of the Neighbourhood Plan with Professor Stanley Roberts and further discussions on the issues and objectives likely to be of relevance and interest to the Parish Council and residents in the coming year. Councillors were in agreement.
4.4 Review of Risk \& Assessment Report and Financial Regulations - The clerk presented a new Risk \& Assessment \& Financial Regs reports which had been previously circulated to councillors for review and discussion. Councillors were happy with the reports which will be reviewed annually. Proposed, seconded and carried.
4.5 Land behind Morningside, Vicarage Road, East Budleigh - The clerk had received correspondence and a map (which was shown to councillors) regarding residents' complaints about the lack of ground maintenance behind their property. The resident's letter will be passed to the local land owner and two councillors will visit the property to discuss boundary ownership and the state of a tree behind their boundary which might be dead and need removal.
4.6 Little Otters Pre-School - Weeks before the imminent closure of the local preschool discussions are taking place between the local primary school and Ofsted to enable them to find a new home within the school. Although it has yet to be confirmed it is hoped that the pre-school will move from the present Village Hall into the primary school after the Easter holidays. The pre-school will operate for 3 days a week. The pre-school have asked the parish council for financial help. It was agreed that the parish council would have to view their accounts before a grant could be considered.
4.7 East Devon Village Plan - A copy of the East Devon Villages Plan has been viewed by councillors who were happy with the Plan and Proposed Submission. The clerk to report councillors' agreement to East Devon District Council.

## 5. MATTERS TO BE DISCUSSED

5.1 East Budleigh Childrens' Play Area - East Budleigh Village Green Update. It was reported that various fund raising projects had been very successful and funds were now in excess of $£ 60,000$ which will be used for the refurbishment of the play area and new equipment.
5.2 Yettington Recreation Room - New sewage works are in place with replacement toilets to be installed. The area will be seeded and fenced as soon as possible.

## 7. REPORTS

7.1 Chairman - The Chair commented on the rumour that a local public house within the village has been sold having been for sale for several months.
7.2 Clerk - The clerk had received enquiries about reservation of car parking spaces for wedding guests. The parish council stated that this was not their policy.
An area of the Recreation field is to be re-seeded and fenced off to allow growth.
The clerk had contacted Ms Bycraft, our internal auditor to ask if she was willing to undertake this task for the financial year 2016/2017. She agreed and a letter of confirmation was sent. Proposed, seconded and carried.
7.3 Drakes School - There are currently 64 children on roll. This term's learning continues with "Code: Puzzles and Patterns". Next term the theme will be about "Pathways" and "Journeys". The new school website is up and running. At present it is the Easter holidays.
7.4 Parish Paths Partnership - Cllr Buss has had a meeting with representatives of Bicton College regarding the help available from Bicton College students which could include maintenance and clearing of P3 paths etc. Bicton College would undertake all of the official needs; insurance, supervision etc. CDE have asked for Risk Assessment and Insurance details from Bicton College before they will become involved.
7.5 Recreation - No report.
7.6 Britain in Bloom - No report.
7.7 Village Hall - The snooker club which forms part of the village hall is to have their fees increased and the village hall will take over the snooker club. It has been reported that there is a danger of asbestos in the hall building.
7.8 East Budleigh Dog Owners Forum - Dog mess has been reported locally. The situation will be investigated by the appropriate councillor.
7.9 East Budleigh Relief in Need - No report.
7.10 Public Conveniences - No problems.
7.11 Any other reports - The first Flood Resilience meeting has taken place and has made good progress. A Working Party has been formed and funds will be required soon in order to proceed.
