#### Minutes of the East Budleigh with Bicton Parish Council Meeting held on Tuesday, 29 March 2016 in the Village Hall, East Budleigh.

#### PRESENT

Prior to the Parish Council meeting, Dr Stanley Roberts, Chair of the Neighbourhood Planning Working Party gave an update on the work of the NPWP prior to the presubmission phase (6 weeks) for residents to offer opinions. It was agreed by all councillors that

The NP must be moved forward as soon as possible and it was important to advertise the NP for residents to view. Hard copies will be available in the Community shop and Information Centre. It can also be viewed on the parish council website w/b 12 April. Dr Roberts and the working party were thanked for their hard work in the production of the draft Plan.

PCSO Chantalle Major was not in attendance but submitted her police report which can be viewed on the parish council notice board.

#### The Parish Council Meeting began at 7.30pm.

It has been proposed and agreed that members of the public be allowed to speak for **3 minutes** at the beginning of the meeting. This time scale will run to maximum of 30 minutes, therefore allowing 10 people to speak. This will bring EBPC in line with other town/parish councils. Members of the public wishing to speak on an Agenda item are requested to inform the clerk no later than 28 March. It should be noted that this is **NOT** a question and answer session, it simply provides a vehicle for the public to make the council aware of views of the public before discussing agenda items.

# 4. MATTERS ARISING

*Parish flooding issues – Rain gauge –* Cllr Tweedie, Mrs Lumsden (clerk), Kate Pearson, and Drakes School Headteacher attended a meeting to update progress of the installation of the rain gauge sited on the allotments. Details of the process to be followed should flooding occur will be sent to relevant flood wardens and other interested parties. Local schoolchildren will using the working of the rain gauge as part of their school projects.

*Emails and Freedom of Information* – Cllr Clarke had no further progress to report.

*Gate at Rec field entrance* – Mrs Clare James (CDE) has offered a wooden gate and post to replace the present one which is rotting away. The councillors agreed to accept this offer and hope to find volunteers to carry out the necessary work involved in refitting the gate and post. The clerk will contact the football club to see if they can help with volunteers.

*Queen's 90<sup>th</sup> Birthday celebrations* – The Chair reported that he is putting together an application for a Community Award featuring the Community Shop. This is being prepared with the help of John Tresidder.
